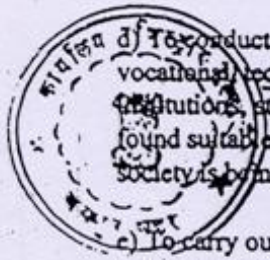





1. Name : The Name is of the society Shri Ganesh Foundation for Education and Research, Jaipur, 2001.
2. Registered Central Office : The registered central office of the society is at present situated in E-198, Ram Path, Shyam Nagar, Sodala, Jaipur-302019, which may also be decided to be changed from time to time by the Executive Council.
3. Area of Operation : The area of operation of the society will be limited to State of Rajasthan.
4. Aims and Objects :

The objectives for which the society is established are :

a) To conduct and promote research in the field of education.

b) To organise lectures, seminars, study groups and workshop on various problems related to education.

c) To promote formal and adult, and women, non-school children education in rural and urban tribal areas utilizing, as far as possible technologies.

d) To conduct and promote studies and research in the field of education be it basic, vocational, technical, management and professional and to establish schools and institutions, study and training centers, research and development centers at any place found suitable for the purpose of furthering and fulfilling such objectives for which the society is being formed.

e) To carry out and undertake research, studies, and survey assignments at our own or on being sponsored by any such other institution or agency, Govt. or non-Govt., from India or abroad for the purpose of social and community development, development of socio-economic conditions of people of any sect or religion belonging to any place inside or outside India and to establish and run institutions and centers for the promotion and development of such objectives.

5. Definitions :

In these rules, unless the context otherwise requires :-

- a) The 'Society' means the Shri Ganesh Foundation for Education and Research, Jaipur
- b) The 'General Body' means the General Body of the society.
- c) The 'Executive Council' means the Executive Council of the Society
- d) The 'Founder Member' means the founder Member of the Society.
- e) The 'Ordinary Member' means the ordinary Member of the Society.
- f) 'Prescribed' means prescribed by law made by the Executive Council and
- g) 'Technical Staff' means the employees of the society engaged in research, extension, publication, teaching or training.

6. Membership of the Society:

The persons having following qualification shall become members of the society :

- i) Residing in area of operation
- ii) He should be major i.e. must have attained the age of 18 years.
- iii) He should not be lunatic or bankrupt
- iv) He should have interest and belief in the objects of the society.
- v) He should watch the interest of the society, supreme.

7. Categories of Members :


The society shall have following categories of Members :

i) Founder Members


Founder Members are those who have resolved to form this society. They shall remain life members of the society.

ii) Ordinary Members

Ordinary members shall be those whose membership is admitted by the Executive Council after the formation of this society.

Except the founder member a person who will be willing to be member of the society shall submit an application for membership to the Secretary who shall put up it for consideration in the next meeting of the Executive Council. If the Executive Council shall have power to except or reject the application on logical grounds.

8. Membership Fee

- a) The fee for membership for per founder member of the society shall be Rs.500/- only.
- b) The membership for the ordinary member shall be Rs. 250/- only.

9. Expulsion from Membership

- i) On death
- ii) On submission of resignation
- iii) On doing any act against the objects of the society.

If found to be guilty by the Executive Council.

∴ The appeal against expulsion shall be filed within 15 days from the date of expulsion to General Body. The decision by majority of the General body shall

10. General Body

i) Membership: All the founder members, Life and Annual members and Patron of the society shall be the members of the General Body of the Society

ii) Meetings: The General Body shall meet at least once a year. The annual general meeting of the General body shall be called by the President of the Society after giving at least twenty one days notice of the date, time, place, and also agenda items to be discussed at the meeting.

iii) Quorum of the meeting of General Body :

One third members of the society shall form a quorum for any meetings of the General Body, but the number of members present in the meeting, should not be less than seven. In the absence of the quorum, the meeting shall be postponed for seven days and after the expiry of seven days the meeting of the General Body shall be called at the same place and there shall be no restriction of any quorum in this

iv) Power and Functions of General Body:

- a) To appoint election officer to conduct the election of the office bearers and other members of the Executive Council.
- b) To appoint Executive Council of the society.
- c) To frame and amend regulations, not in consistent with the Memorandum of the society, for the administration and management of its affairs.
- d) To make amendments in the Memorandum and Constitution of the Society by 2/3 majority of total members.
- e) To make policy and action plan of the society for ensuing year.
- f) To consider the Annual Report placed by Executive Council.
- g) To consider the Audited accounts of the out going years.
- h) To appoint auditors for the ensuing year.
- i) To decide any other matter on the agenda.

v) Special Meeting of the General Body :


The special meeting of the General Body may be called on the following circumstances:


- a) If the Executive Council feels the need for it,
- b) If the third members of the Society demand for it.

vi) Election of the Executive Council :

The General Body shall elect the members of the Executive Council. Election shall be open to all, however 2 or 3 seats may be reserved for Founder Members. The method of election shall be direct or indirect as to be decided by the members of the General Body before starting election. Winning candidates shall require simple majority of the members present and voting in the meeting.

- a) The President, or in his absence the Vice President shall preside over the meeting of the General Body.

b) No items other than the agenda items of the meeting shall be discussed in the meeting of the General Body except with the permission of the presiding officer.

c) Every member of the General Body shall have one vote and in case of equality of votes the presiding officer shall have a right of a second or casting vote.

11. Composition of Executive Council :-

i) The Executive Council of the society shall be composed of the following seven persons :

President	-	One
Vice President	-	One
Secretary	-	One
Treasurer	-	One
Members	-	Three

Thus there shall be four office bearers and three members of the Executive Council. The total members shall be seven.

ii) Term: The Executive Council shall hold office for a period of five years from the date of its constitution.

iii) Meetings of the Executive Council :

There shall be at least four meetings of the Executive Council in a year, but whenever necessary the president or the Secretary may call the meeting at any time.

b) The Quorum of the meeting shall be more than half of the total members of the Executive Council.

c) The notice of the meeting shall be given seven days before the date of meeting.

d) In the absence of quorum, the meeting shall be postponed, but the meeting may be called next day or on the day as convenient, and no quorum shall be necessary for such meeting. But the agenda items shall be the same. The presence of two office bearers is necessary in this meeting.

iv) Casual Vacancies: any casual vacancy amongst the members of the Executive Council, arising from death, resignation, removal or otherwise may be filled by co-option by the executive council and the member so co-opted shall hold office for the unexpired portion of the term of the office of the member causing the vacancy.

notwithstanding any defect in its constitution and no act or proceeding of the executive council shall be invalid by reason only of the existence of any vacancy amongst its members or any defect in its constitution.

(v) Power and Functions of Executive Council

(a) The executive council shall be responsible for the management and administration of the affairs of the society in accordance with these rules and the bye-laws made thereunder for the furtherance of its objectives and shall have all power which may be necessary or expedient for the purpose.

(b) Without prejudice to the generality of the power conferred by the fore-going sub-rule, the Executive Council shall have the power :

(i) to admit membership

(ii) to prepare and execute detailed plans and programmes for the furtherance of the object of the society.

(iii) to receive, to have custody of and to expend the funds of the society and to manage the properties of the society;

(iv) to appoint and control such staff as may be required for the efficient management of the affairs of the society and to regular their recruitment and conditions of services

(v) to enter into agreements for and on behalf of the society;

(vi) to sue and defend all legal proceeding on behalf of the society.

(vii) to expel any person from membership if he does any act contrary to the memorandum, constitution or rules of the Society, or does any act against the interests of the society.

(viii) to approve the annual budget of the society.

(ix) to appoint auditor to conduct the audit of accounts of the society.

(x) to appoint sub committees from amongst the members of the Executive Council for the specific purposes fulfilling the objects of the society.

(xi) to invest and deal with funds and money of the society.

(xii) to construct, maintain, alter, develop any buildings or works necessary for the purpose of society.

12. Powers and Rights of the office bearers of the Executive Council :

A. President :

- a) He shall be responsible for the functioning of the Society.
- b) He shall preside over the meetings of the General Body, and the Executive Council.
- c) He shall be ex-officio chairman of any selection committee constituted for the recruitment of academic and administrative staff for the society.
- d) If there is equality of votes in the meeting of the Executive Council or General Body, he shall have the power of second vote or casting vote.
- e) to present the society.

B. Vice- president

- a) He shall preside over all the meetings of the Executive Council and General Body in the absence of the president and discharge all his functions and responsibilities .
- b) In the absence of the President, he shall exercise the powers of president.

C. Secretary

- a) He shall be responsible for looking after the general administration, management and other activities of the society .
- b) He shall be responsible for calling meeting of both the executive committee and the general body.
- c) He shall be responsible for all the correspondence and related matters relating to Shri Ganesh Foundation for Education and Research.
- d) He shall keep records of the meetings of both the General Body and Executive Committee and shall seek their confirmation in the next meetings.
- e) He shall also maintain all the required and relevant records of the society.
- f) He shall be responsible to cause annual audit of the society by an auditor appointed by the Executive Council and compliance thereof.

D. Treasurer

- a) He shall keep all the accounts of the society and shall be responsible for controlling

b) He shall be responsible for withdrawals and payment of the funds of the society.

E. The source of funds will be as follows :

a) Donation

b) Subscription

c) Contribution

d) Fees

e) Aid

f) Government Grant

g) The bank account shall be operated by joint signatures of any two of the following office bearers :

i) President

ii) Secretary

Looking to the necessary work and time in the interest of the society, the following office bearers shall have the power to sanction lump sum amount by his single signature :

i) President - Rs. 10,000/- only
ii) Secretary - Rs. 5,000/- only
iii) Treasurer - Rs. 2,000/- only

13. Audit of the Society.

The accounts of the society shall be audited annually, by the auditor to be appointed by the Executive Committee.

14. Amendments to the Constitution

Any amendments, additions or changes in the rules and regulations of the society shall be made according to the section 12 of Rajasthan Societies Registration Act, 1958.

15. Dissolution of the Society

The dissolution, if any of the society shall be according to the sections 13 and 14 of the Rajasthan Societies Registration Act, 1958.






